

“BRAS N THINGS REWARDS FIJI PROMOTION”

HOW TO ENTER

To be eligible to enter the draw, individuals who are members of the Bras N Things Rewards Program must present their Bras N Things Rewards card at the point of sale when they make a qualifying purchase at any Bras N Things store between 3 February 2012 to 4 March 2012. A qualifying purchase is defined as a purchase of \$5.00 (AUD for Australian residents and NZD for New Zealand Residents) or more for existing and newly enrolled Bras N Things Rewards members.

With each qualifying purchase made, the entrant will receive a voucher containing a unique code. To enter the draw, entrants must, during the promotional period, visit www.brasnthingsrewards.com.au, follow the prompts to the competition entry page, input all requested details including the unique code found on the voucher and submit the fully completed entry form.

TERMS AND CONDITIONS

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is only open to Australian and New Zealand residents aged 15 years or older who are members of Bras N Things Rewards. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this promotion. The winner will be notified by phone and in writing within two (2) business days of the draw and the winner of the major prize will have their name published in The Australian on 20 March 2012. The Promoter's decision is final and no correspondence will be entered into.
